About this Report::

This report summarizes fall enrollment for Wayne State University. This report uses the Registrar's enrollment data as the fall census date.

Definitions

Credit Hour—A credit hour is defined as one class hour per week or its equivalent.

First Time in Any College (FTIAC) - A full- time or part- time student attending any institution for the first time. Includes students enrolled in the fall term who attended a postsecondary institution for the first time at the same level in the prior summer term. Also includes students who entered with advanced standing (college credit earned before graduation from high school).

Full Time Student (Fall/Winter Semester): A student at the following level must be enrolled in the following amount of credit hours per term, regardless of the level of the course: Undergraduate, 12 or more credit hours; Graduate, 8 or more credit hours; Professional (excluding Medical students), 10 or more credit hours; Medical 24 or more credit hours (per Medical year).

Full Time Equivalent (FTE) Students (using fall student headcounts): The number of FTE students is a calculation based on fall student headcounts as reported to IPEDS. The FTE for part time students is calculated by multiplying the part time headcount by a factor determined by student level and added to the full time student headcount to achieve a full time equivalent headcount.

Graduate Student—A student who holds a bachelor's or first professional degree, or equivalent, and is enrolled in a graduate program.

Headcount (Enrollment)—Number of students enrolled at the institution as of census date of the term, the tenth day of classes. Each student equals one headcount, regardless of the credit hours taken.

Non-Resident Student—A student with a legal residence outside of Michigan.

Professional student-- A student enrolled in either the Medical Doctor program, Doctor of Pharmacy program, or Juris Doctor program.

Resident Student—A student having a legal residence in Michigan.

Transfer Student—A student entering the reporting institution for the first time but known to have previously attended a postsecondary institution at the same level, e.g. undergraduate, graduate and has earned credit at that institution.

Undergraduate student—A student enrolled in a bachelor's degree program or post-bachelor certificate program; includes non-degree-seeking students who do not have a bachelor's degree.

Executive Summary of Changes From Fall 2010 to Fall 2011

- Headcount enrollment change
 - Total headcount decreased by 740 students (-2.4%).
 - Undergraduate headcount decreased by 248 students (-1.2%).
 - Graduate level headcount decreased by 410 students (-4.9%).
 - Professional level headcount decreased by 82 students (-3.7%).
- Credit hour enrollment change
 - Total credit hours decreased by -8,863 credits (-2.8%).
 - Undergraduate credit hours decreased by -5,572 credits (-2.4%).
 - Graduate level credit hours decreased by -2,315 credits (-4.2%).
 - Professional level credit hours decreased by -976 credits (-2.3%).
- First Time in Any College (FTIAC) undergraduate headcount decreased by 217 (-8.1%) students and 2,349 (-6.7%) credit hours.
- Transfer undergraduate enrollment headcount grew by 181 (9.5%) and 1,290 credit hours (6.2%).
- Minority total enrollment headcount decreased 547 (-4.8%).
- Total international enrollment headcount declined by 75 students (-4.4%).
- The average ACT composite score and average high school grade point average of incoming FTIAC's improved to 22 and 3.27 respectively, up from 20.9 and 3.17.
- The full-time FTIAC (degree-seeking) one year retention (freshman returning a second year) remained stable at 77%.
- The four-year graduation rate increased from 10% to 11%.
- The five-year graduation rate increased from 20% to 21%.
- The six-year graduation rate decreased from 31% to 26%.

Total Fall Enrollment

The fall 2011 total enrollment headcount decreased from the fall 2010 count of 31,505. This represents a decline of 2.4 percent. Total credit hours decreased by 8,863 or 2.8 percent.

Over 80 percent of WSU's students came from the Wayne, Oakland and Macomb county areas; 91 percent of Wayne State students were Michigan residents. Since 2006, the demographic for student residency has remained around 90 percent for Michigan residents.

The percentage of undergraduate students that are full-time versus part-time has increased 4.8% in the past four years with the majority taking 12 or more credit hours per semester.

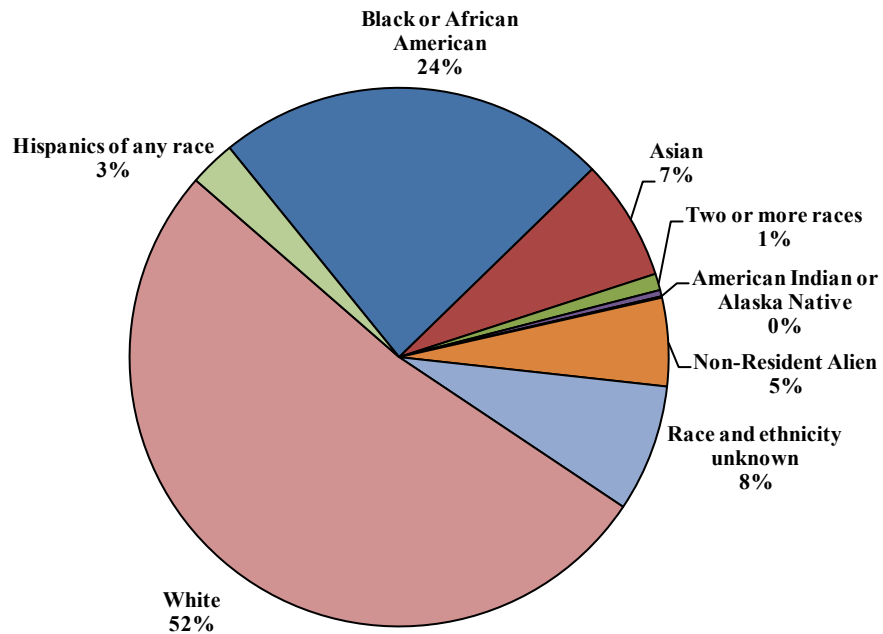

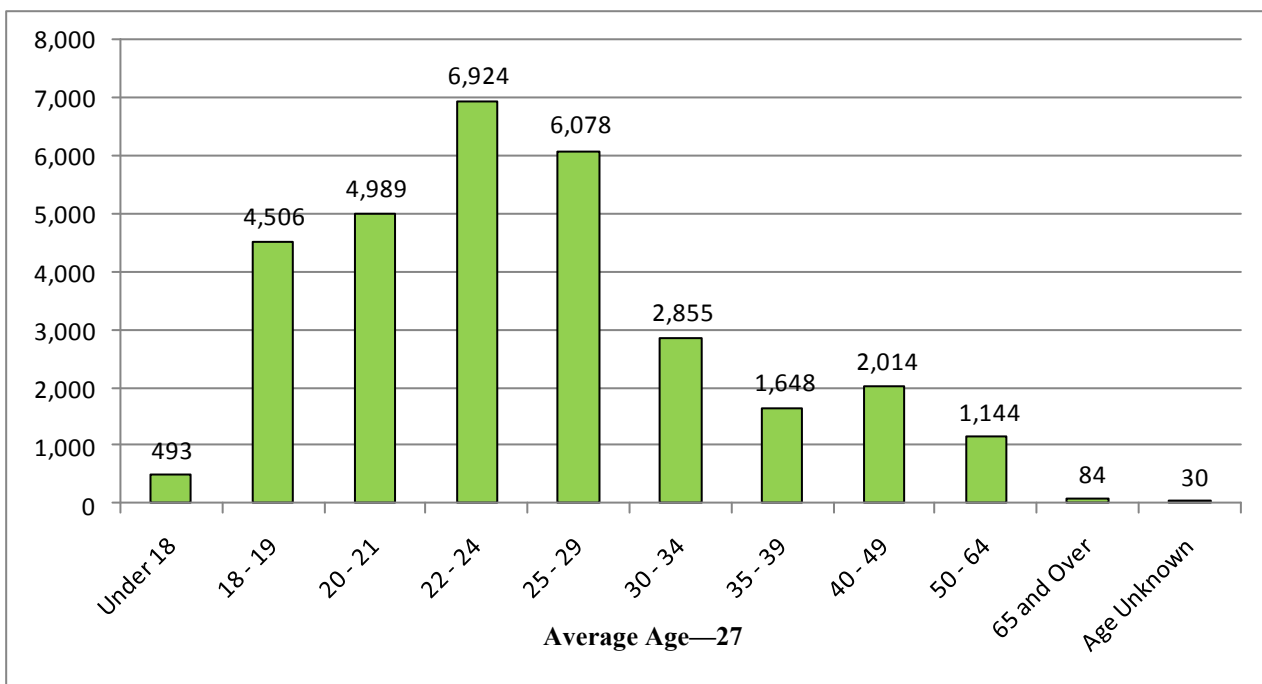

120 Fall 2010 students were transferred from CLAS Computer Science Department to Engineering Comp. Sci. department. Overall, the total number of Computer Science students increased from 223 in Fall 2010 to 445 (100%) in Fall 2011, with a 65% decline in CLAS Comp. Sci. enrollment.

Fall 2011 Total Enrollment by Race/Ethnicity

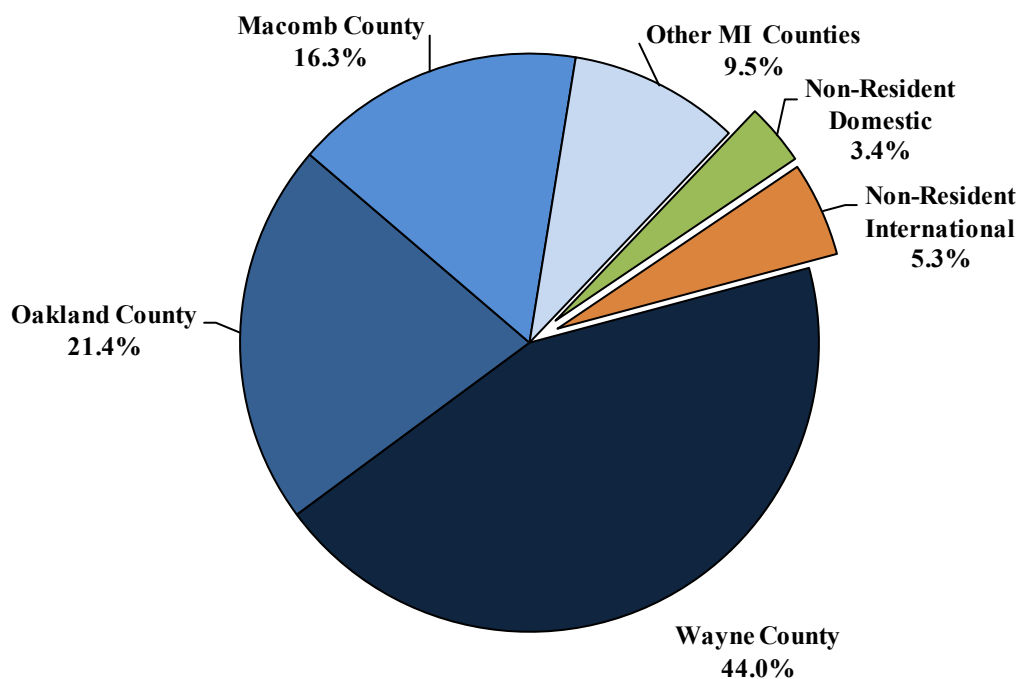


Fall 2011 Total Enrollment by Age

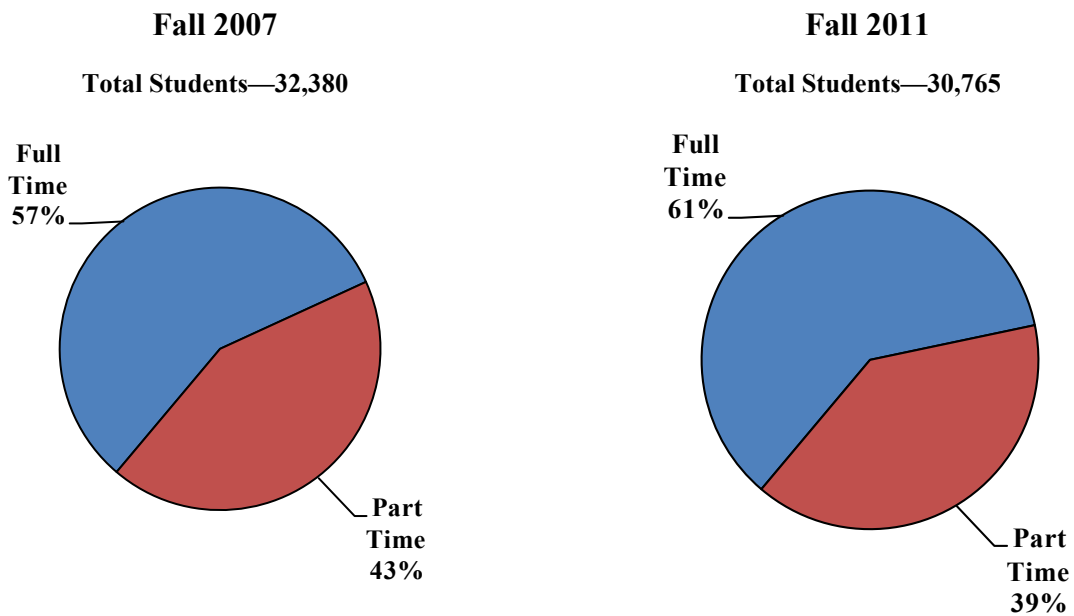

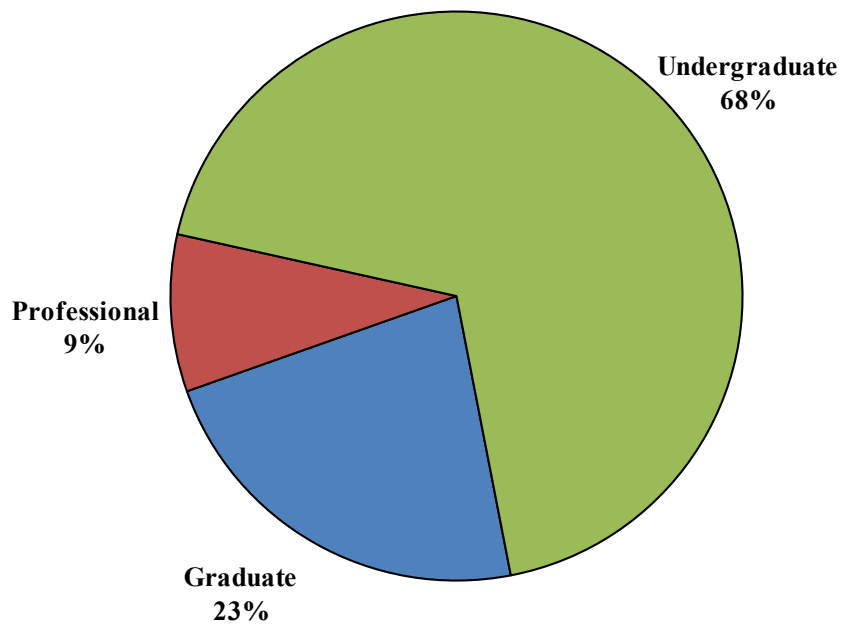

Undergraduate Fall Enrollment

The undergraduate fall enrollment headcount and credit hour totals declined since fall 2010 including an 8.1 percent decrease in FTIAC enrollments and a 2.4 percent decrease in credit hours. This decrease was the result of fewer students being admitted into the DCE program for fall 2011.

The fall 2011 average undergraduate credit hour load was eleven credit hours. Of the incoming freshmen, 90 percent are full-time students.

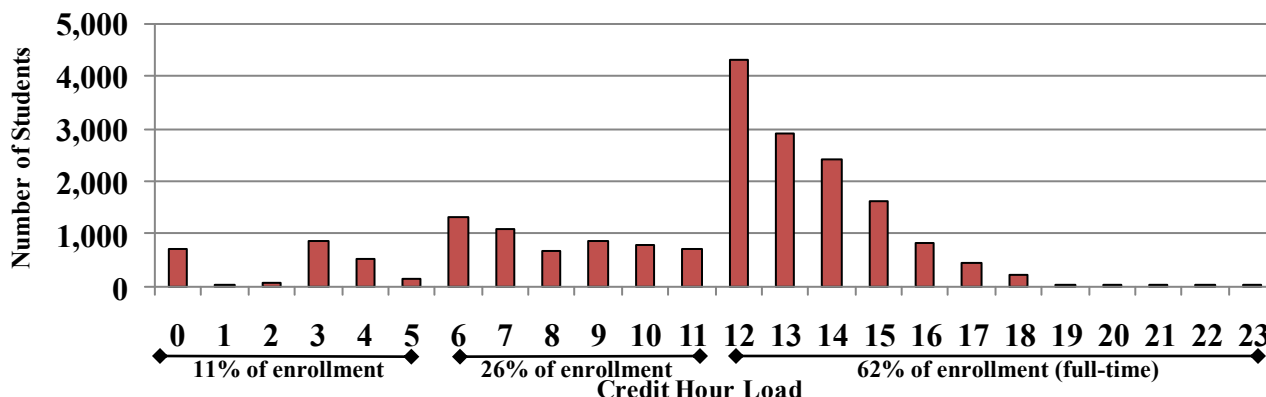

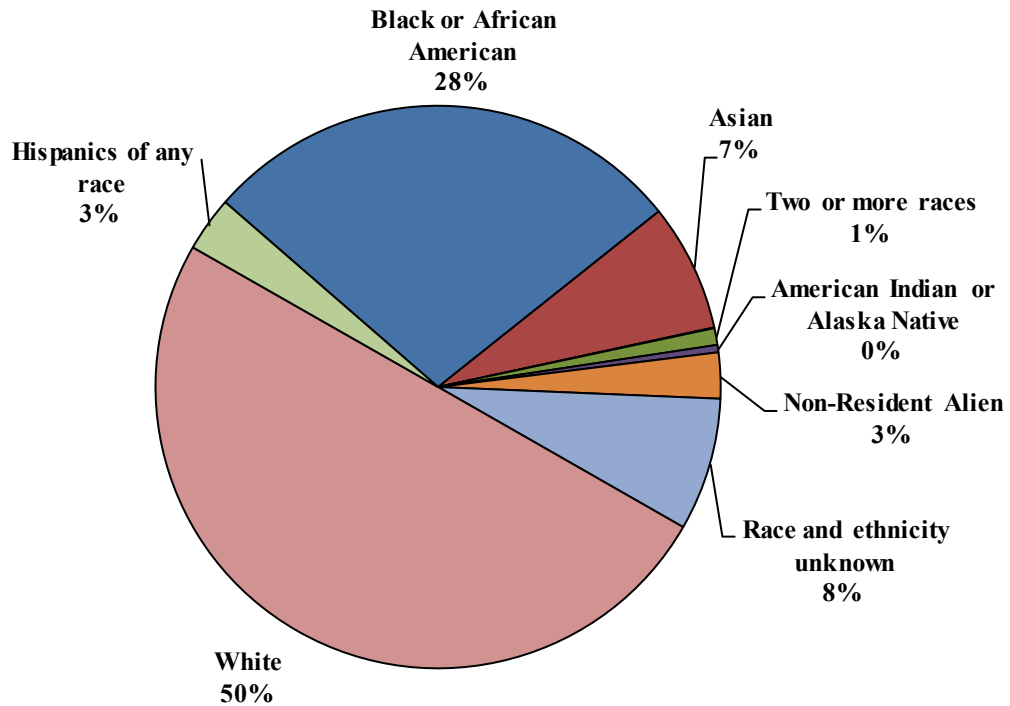
Fall 2011 Undergraduate Student Credit Hour Load Distribution



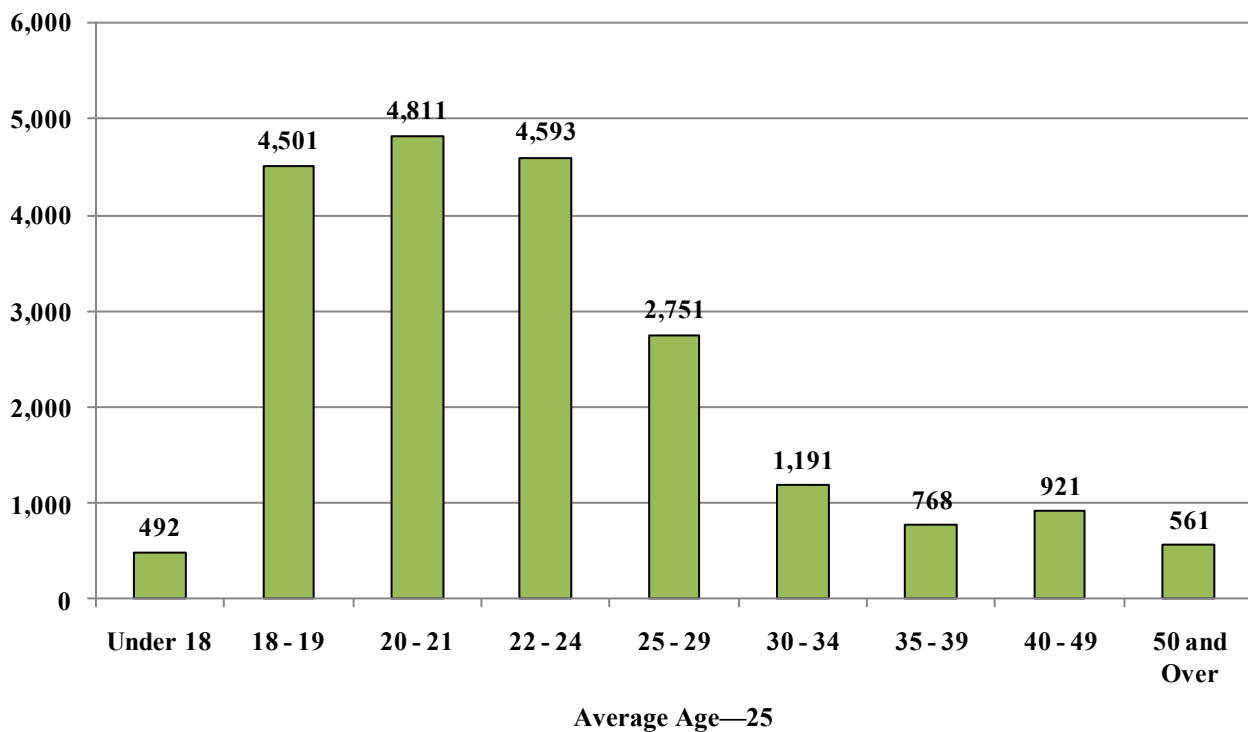

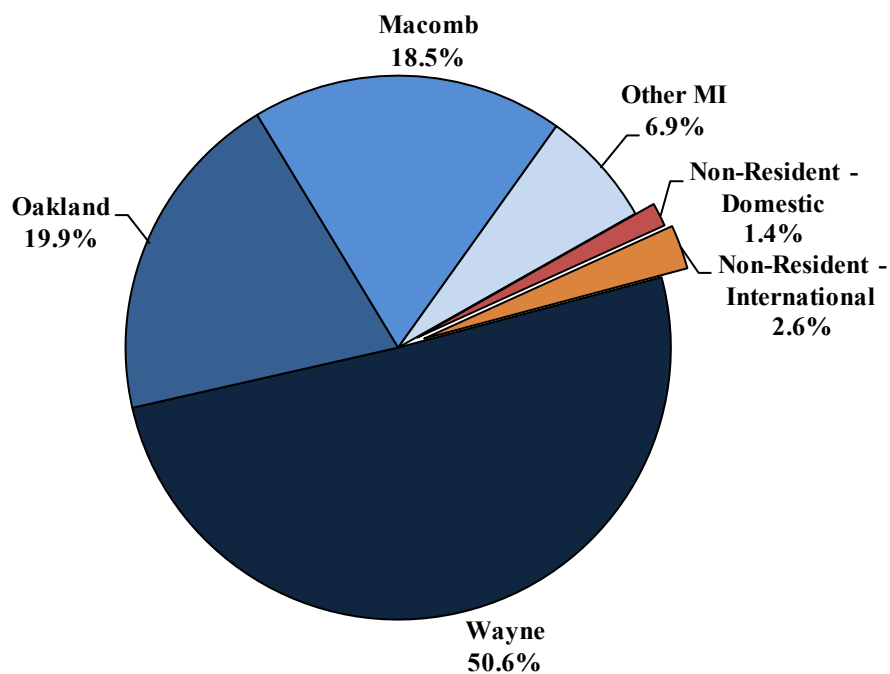
Fall 2011 Undergraduate Enrollment by Race/Ethnicity

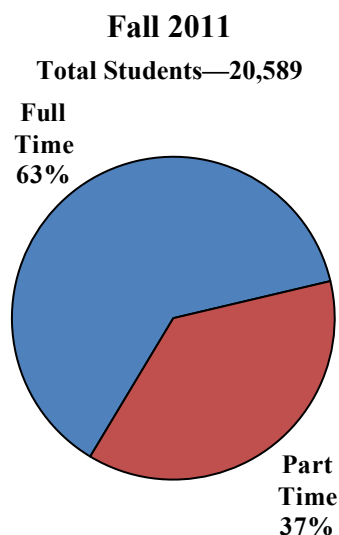

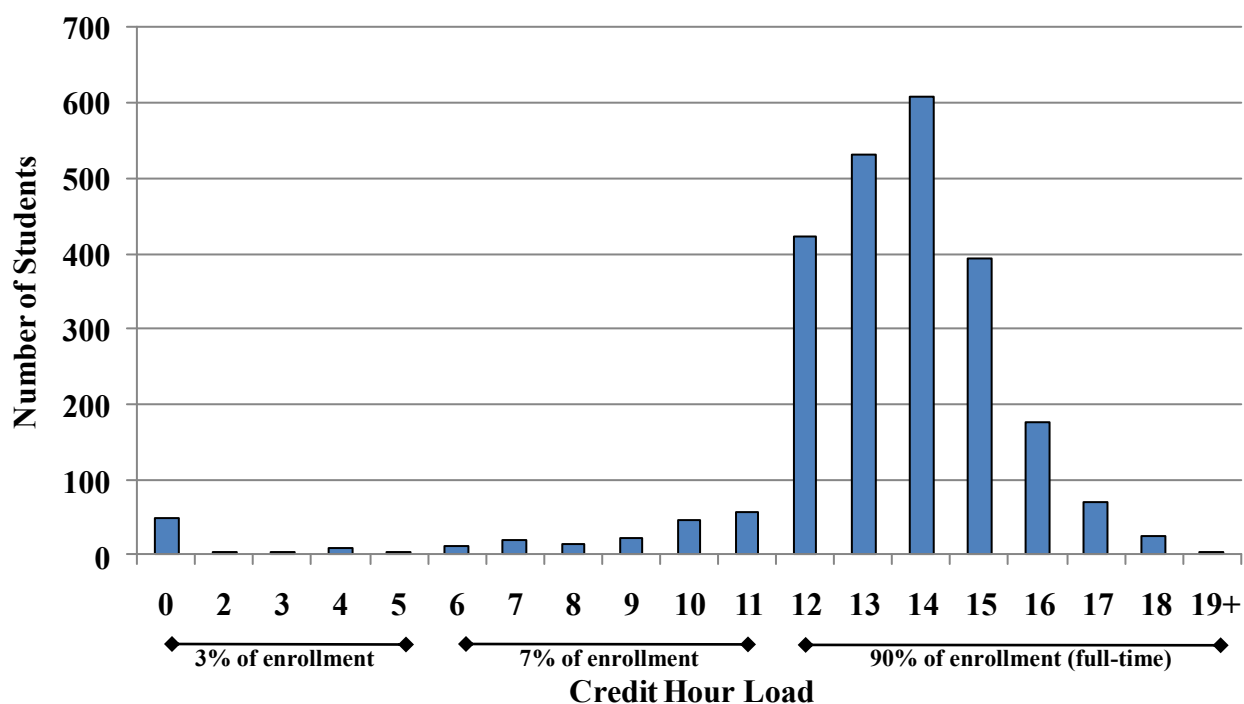

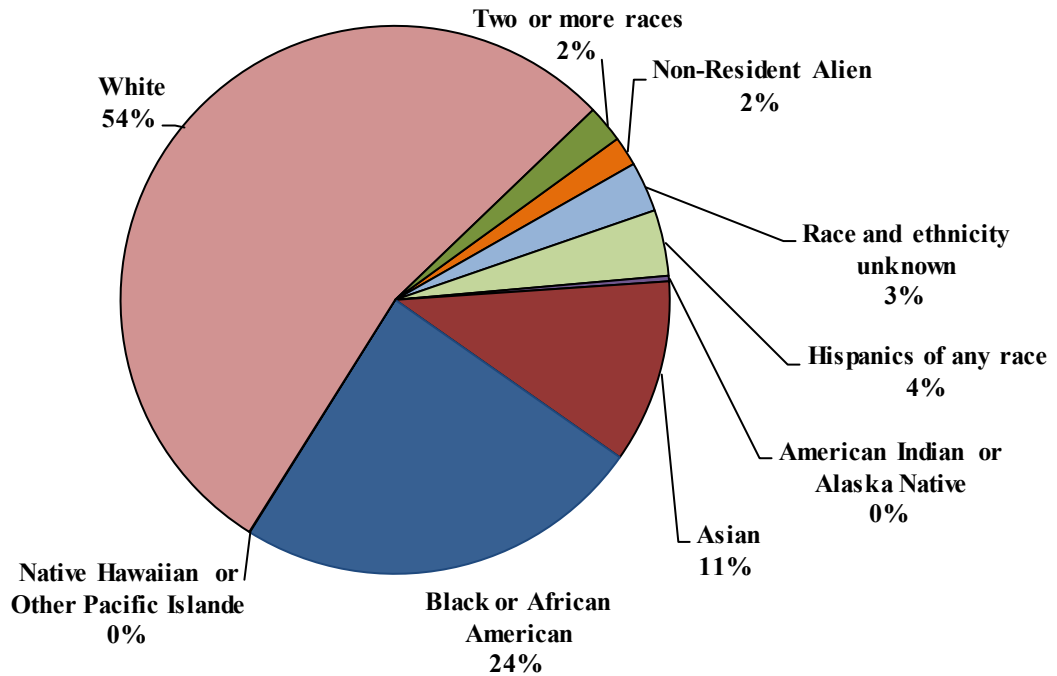

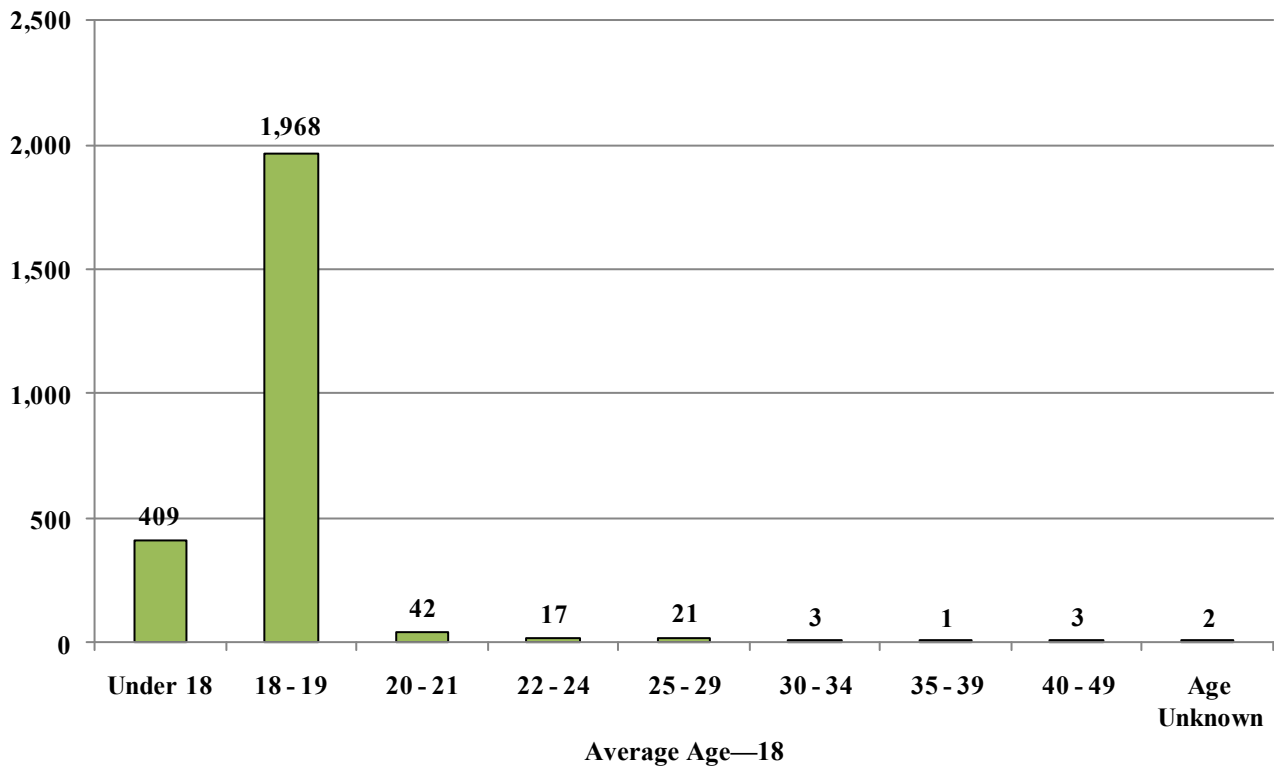
Fall 2011 FTIAC Student Credit Hour Load Distribution



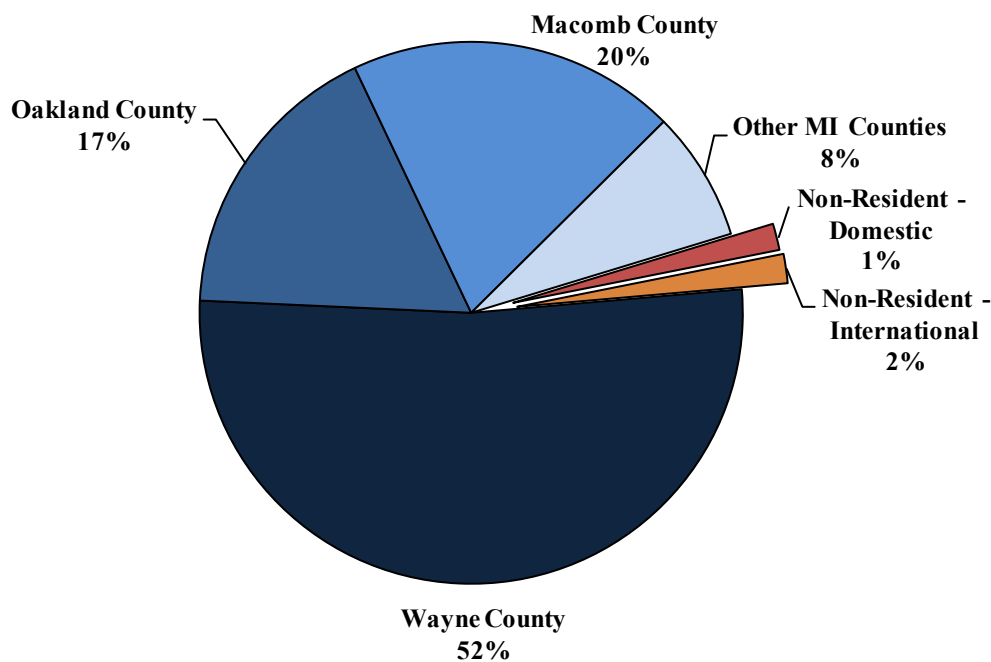
Fall 2011 FTIAC Enrollment by Race/Ethnicity

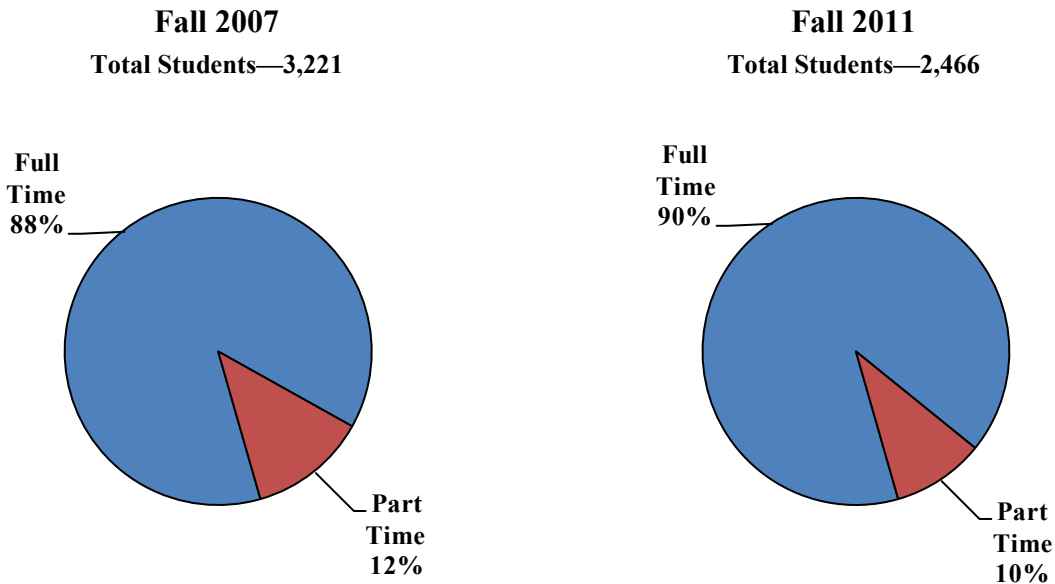

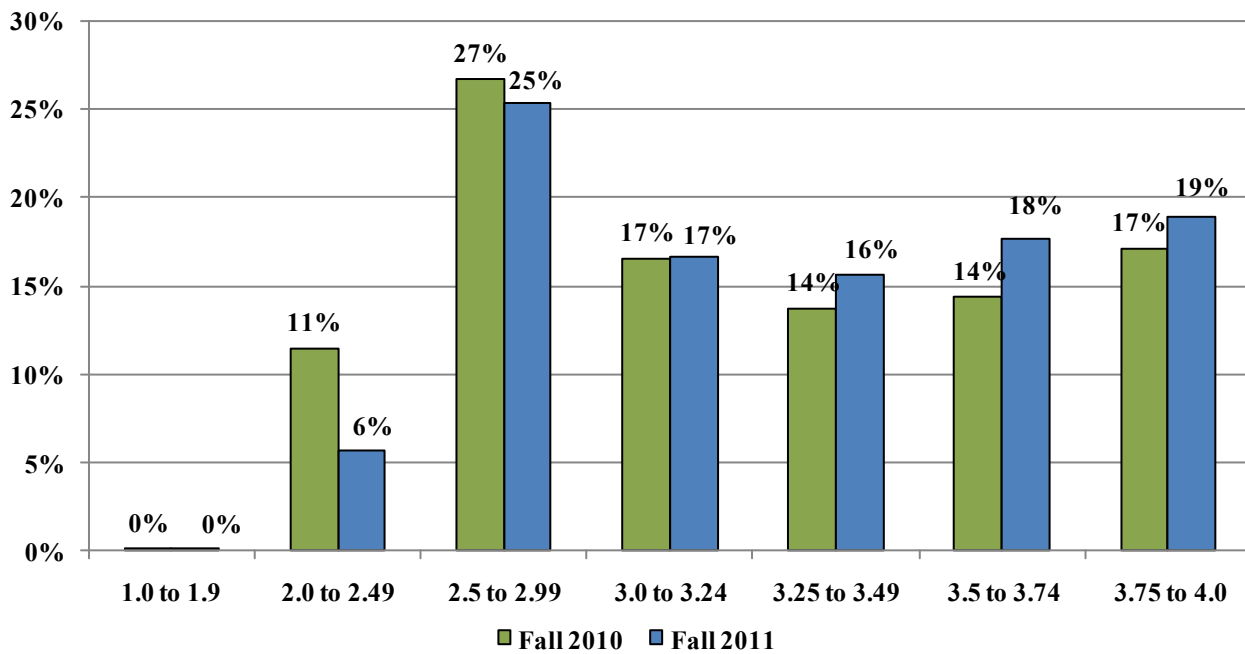

Fall FTIAC Enrollment by Time Status Comparison

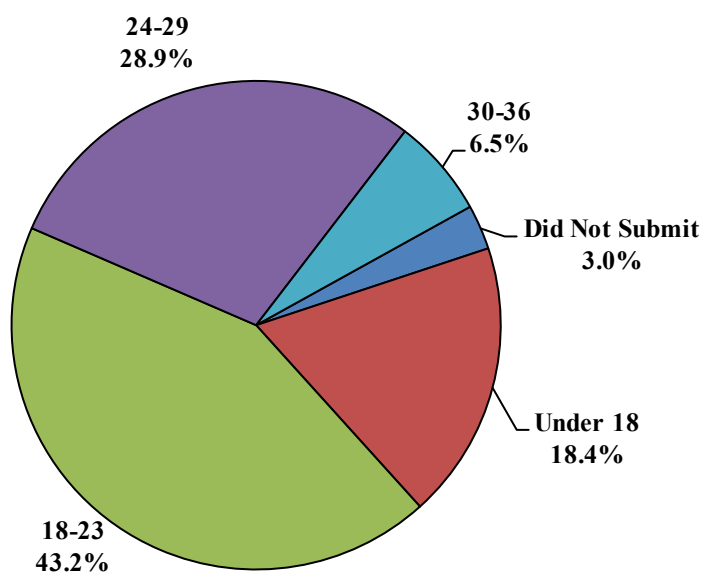


Fall 2011 FTIAC High School Grade Point Average

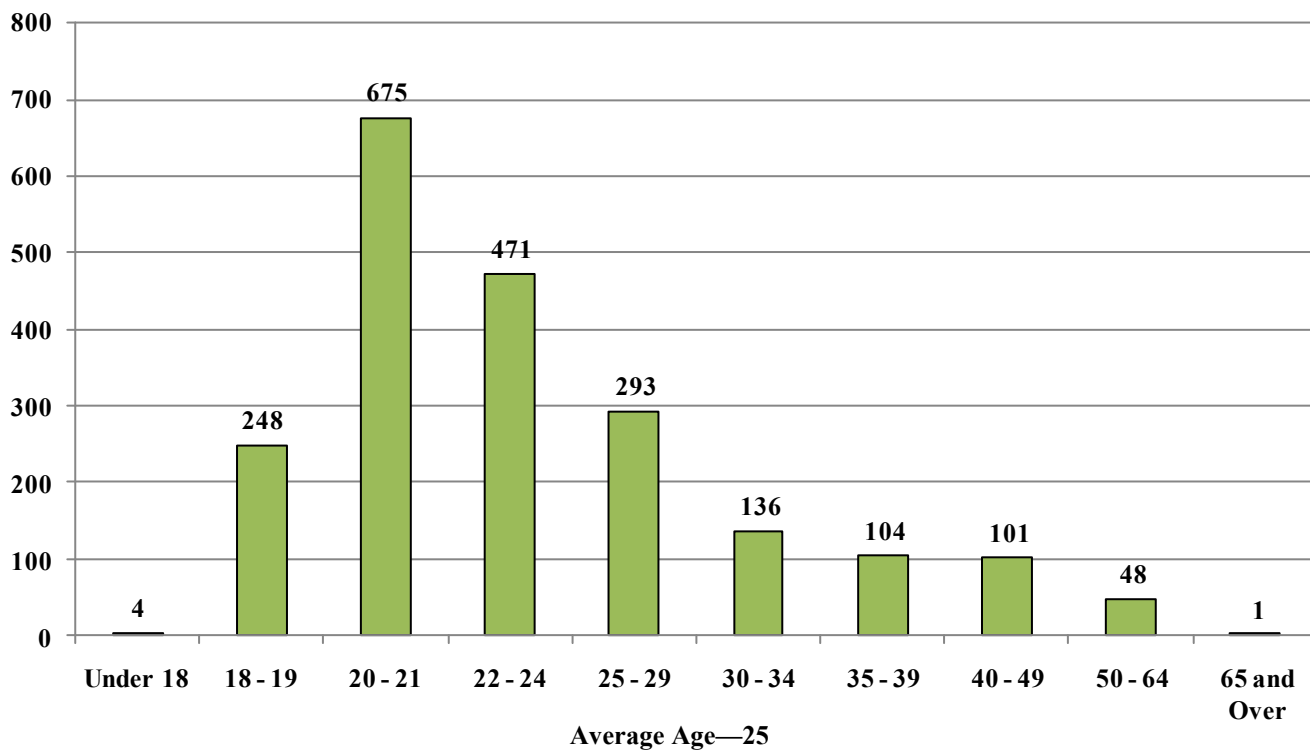

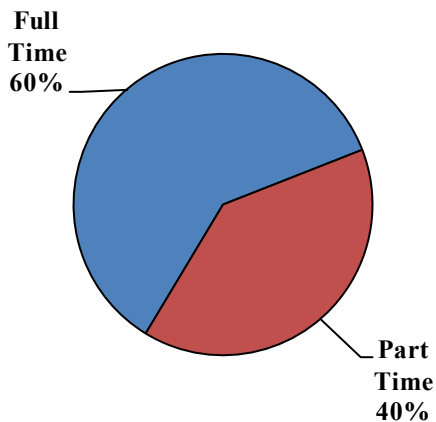
Fall 2011 Transfer Enrollment by Age



Fall Transfer Enrollment by Time Status Comparison

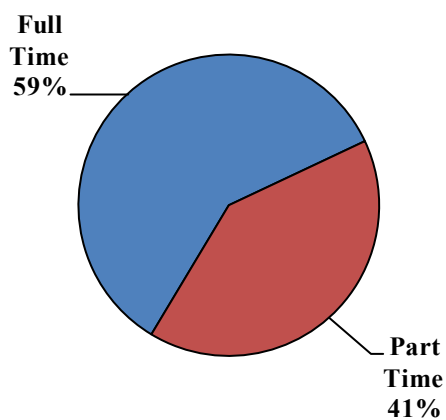

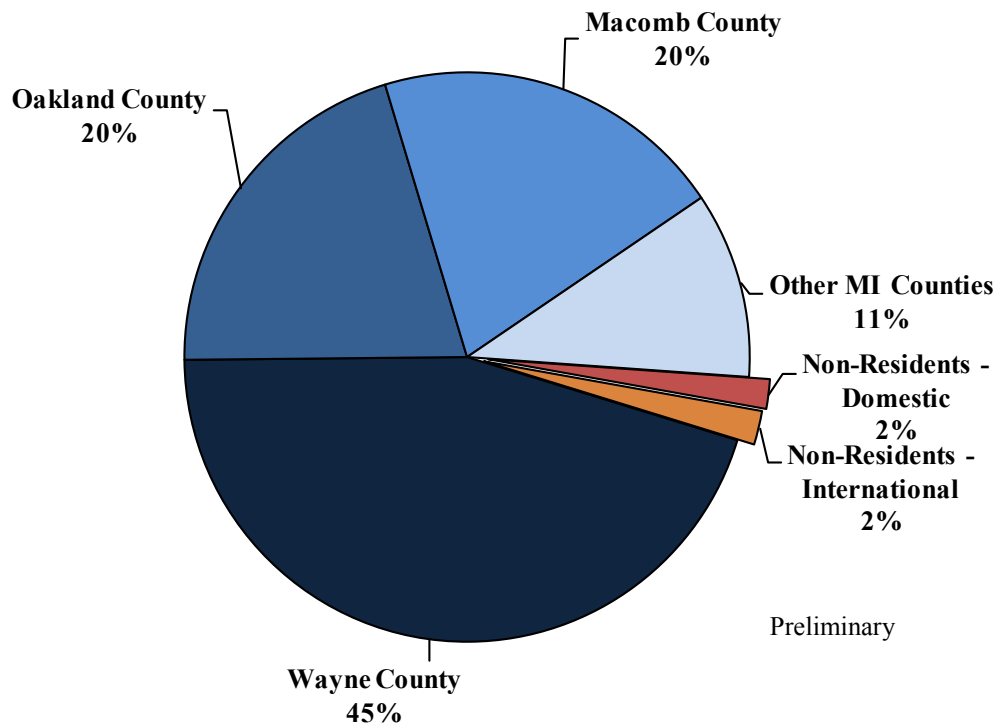

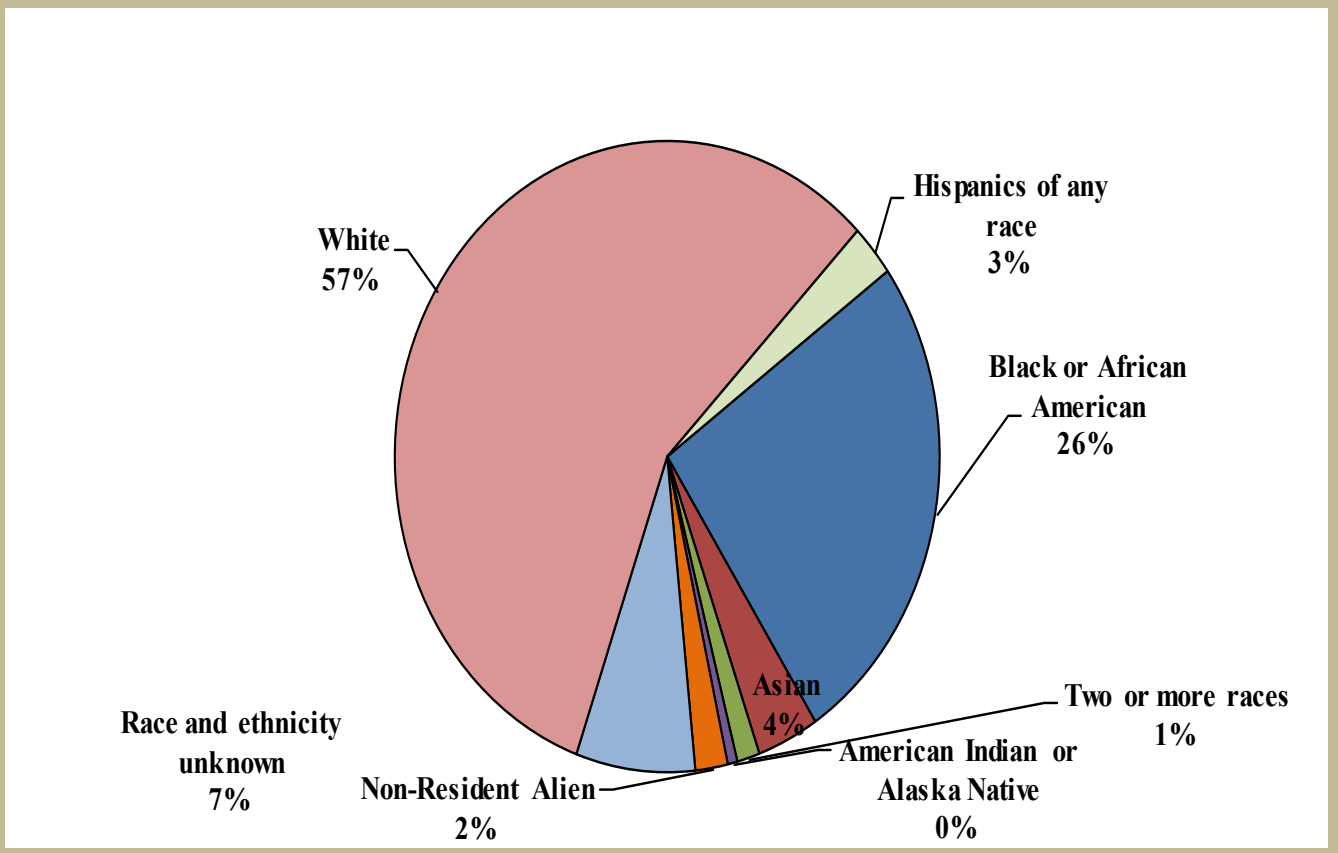

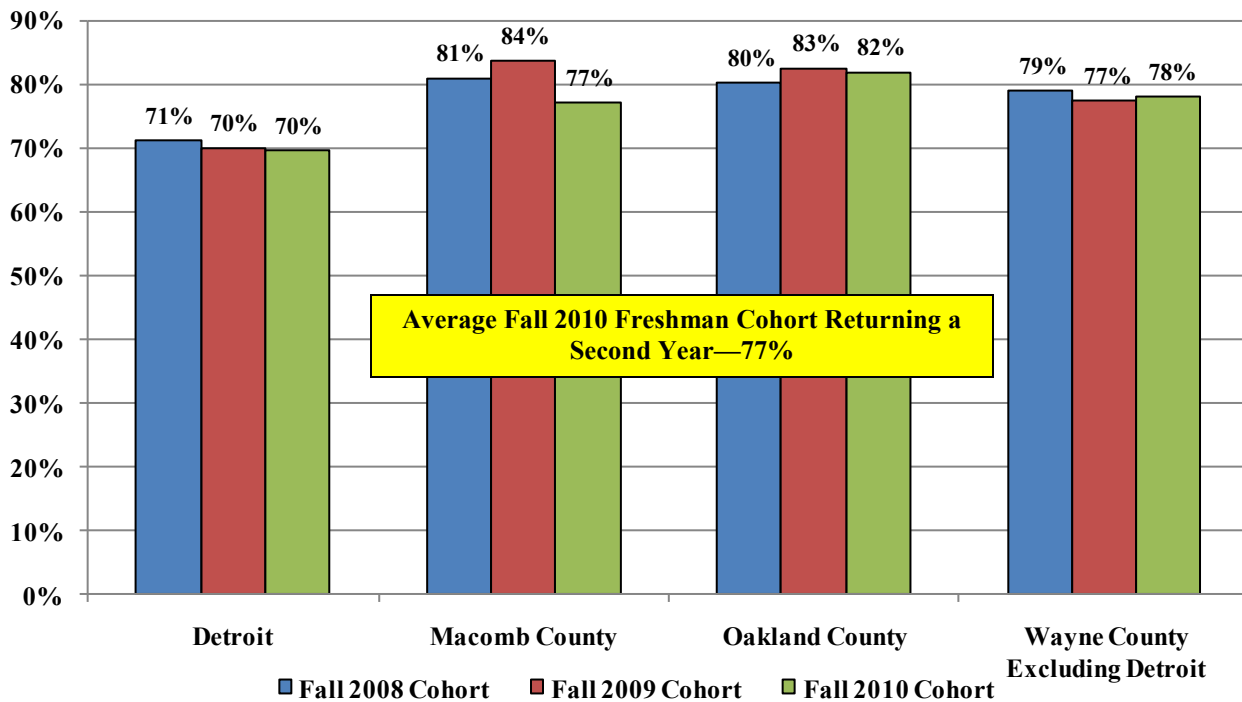

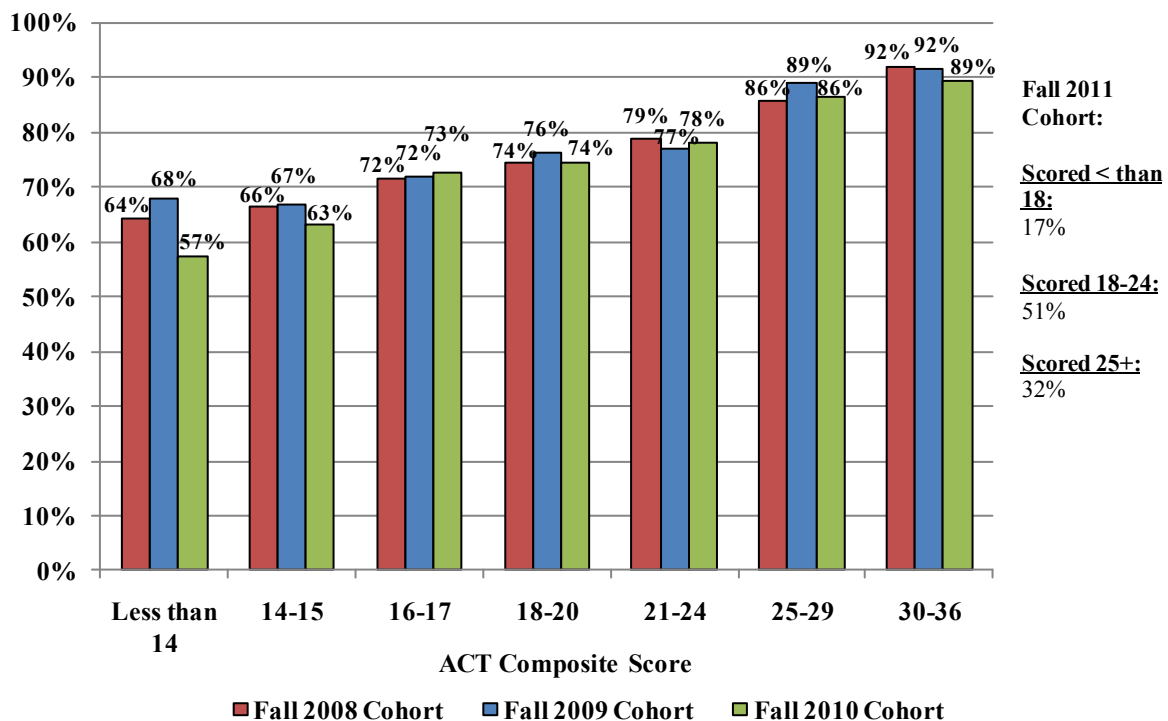

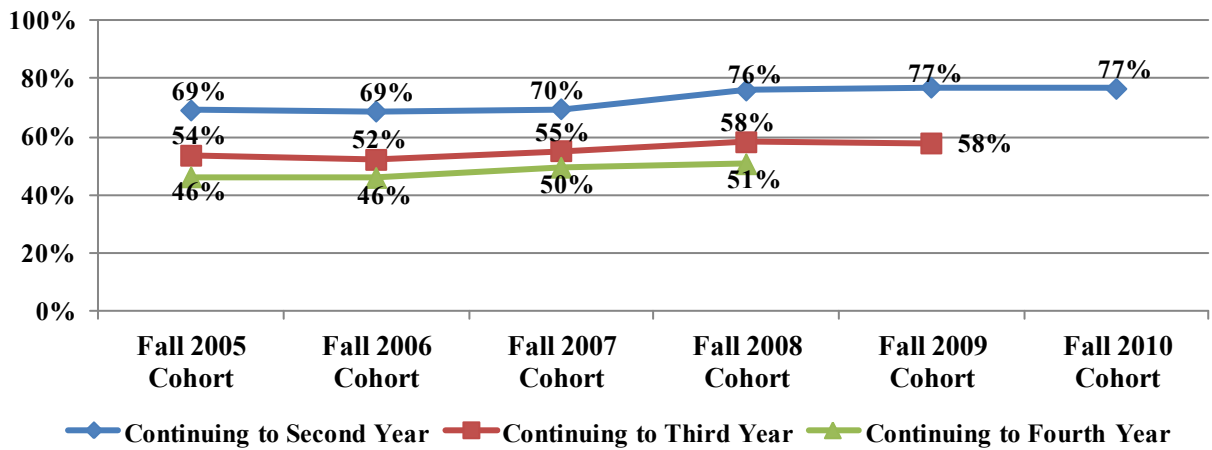
Tri-County Fall Full-time Freshman to Second Year Retention



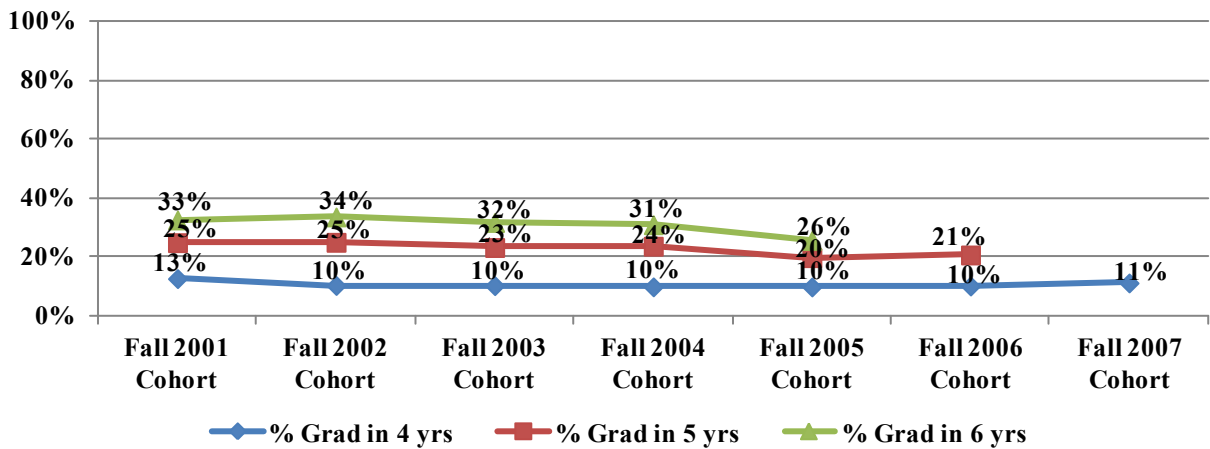
Fall Full-time Freshman to Second Year Retention by ACT Composite Score

Undergraduate Multi-Year Graduation Rates

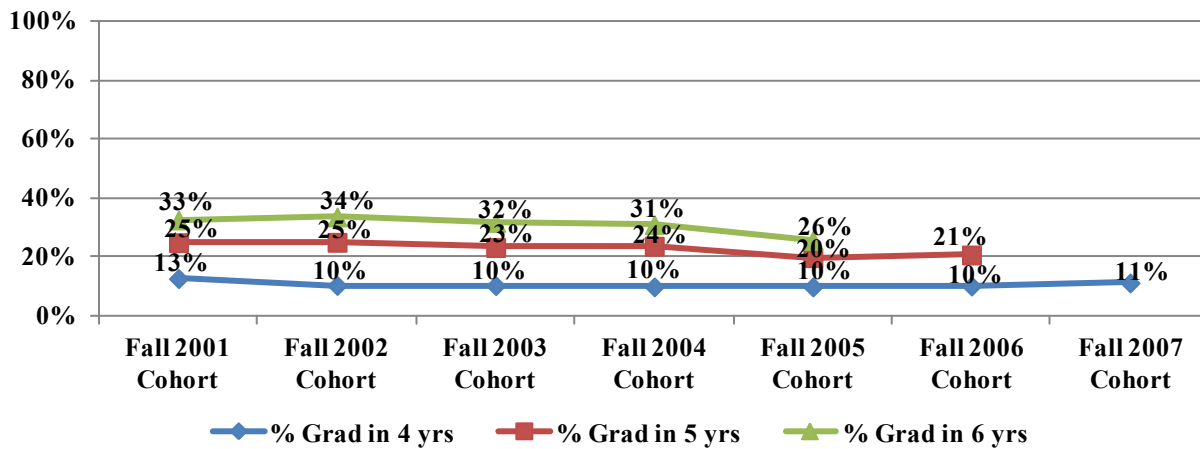

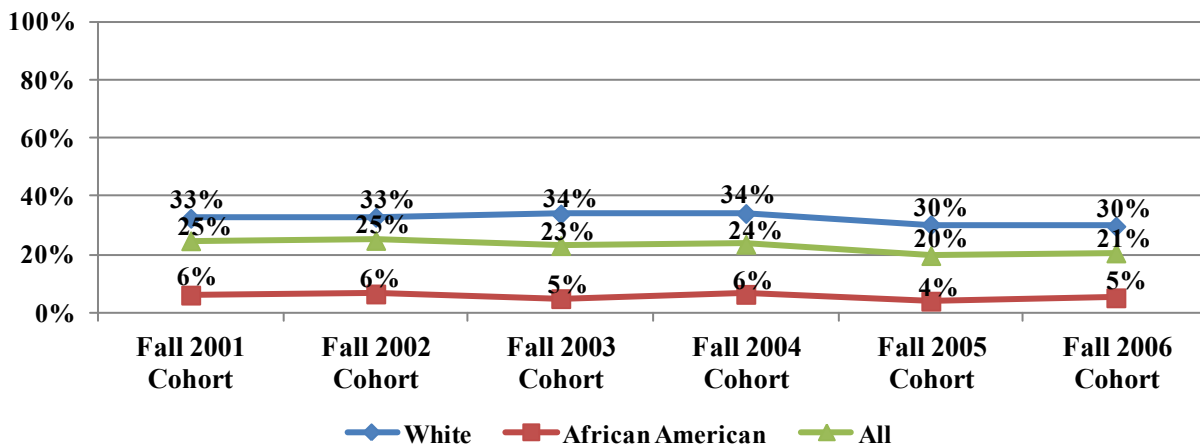

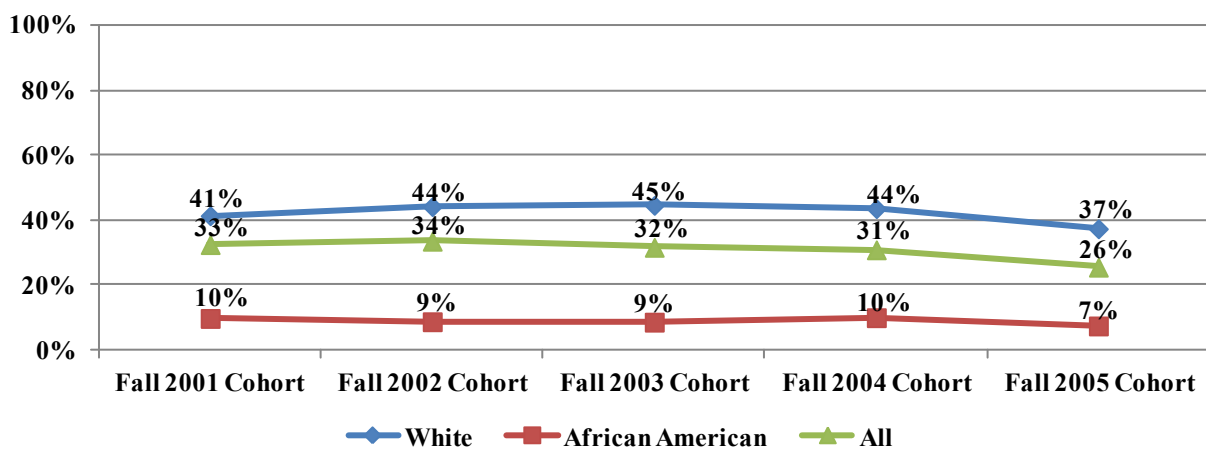
Undergraduate Four-Year Graduation Rates by Race/Ethnicity

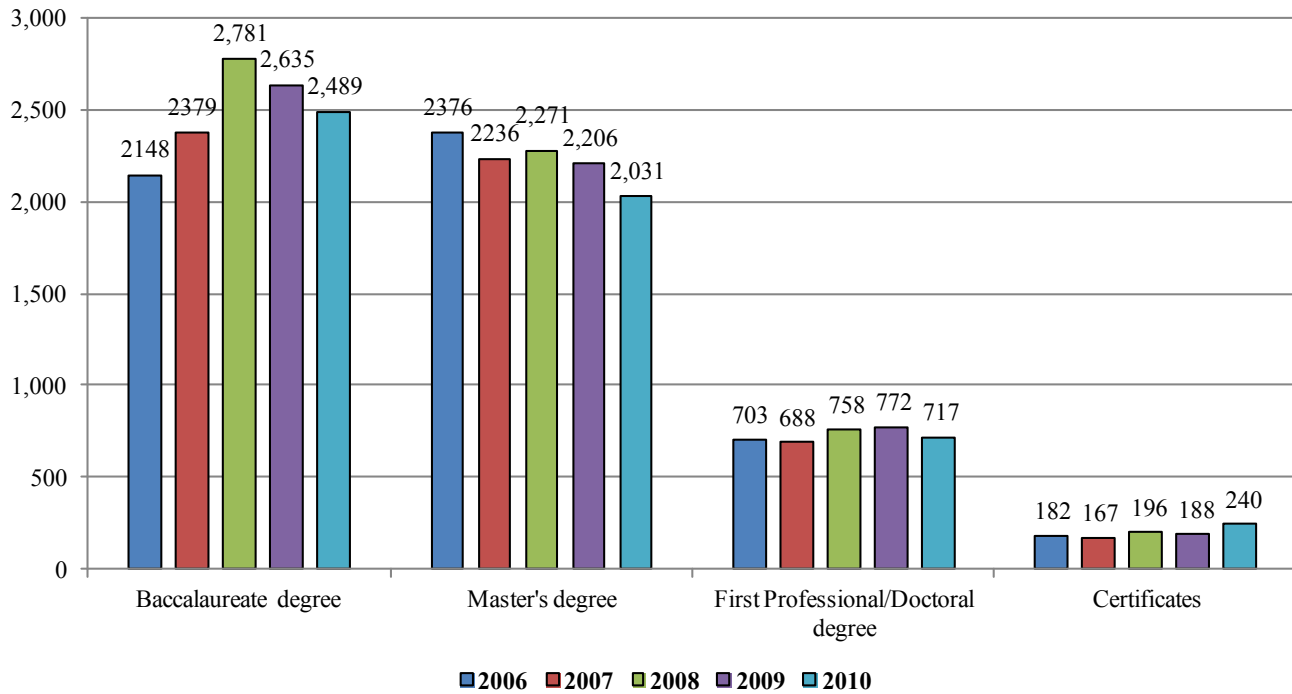

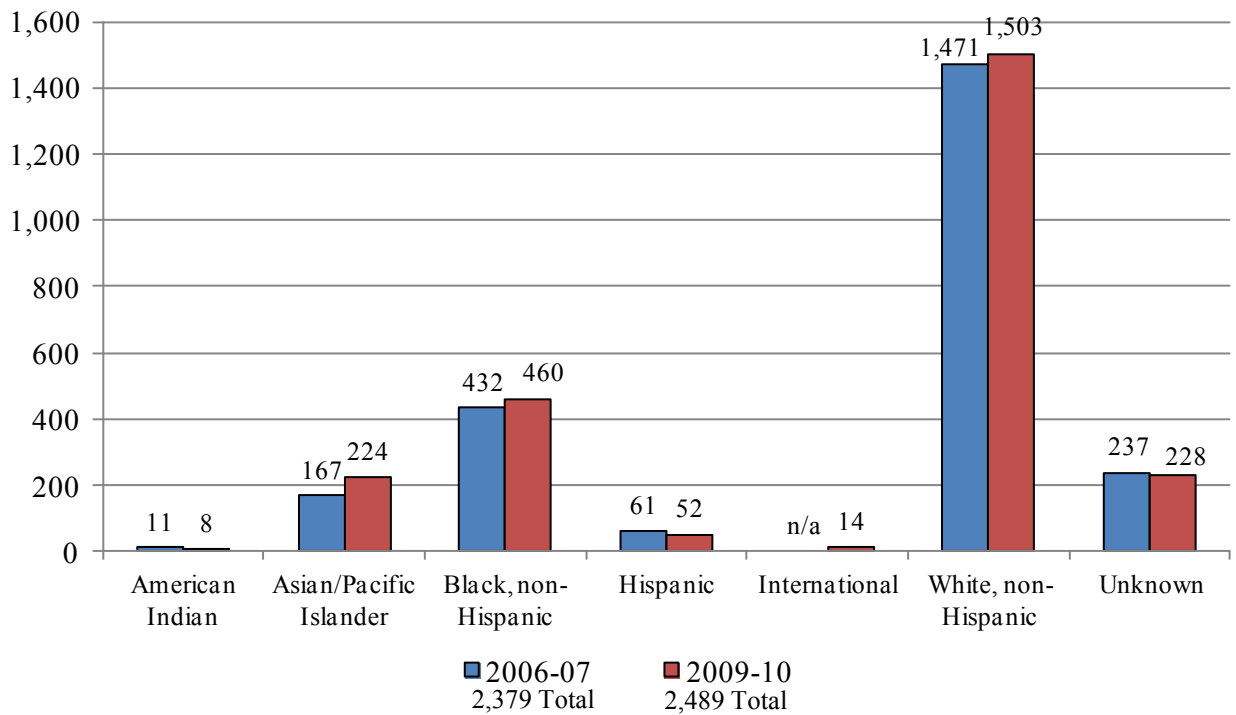
Number of Degrees and Certificates Granted by Type



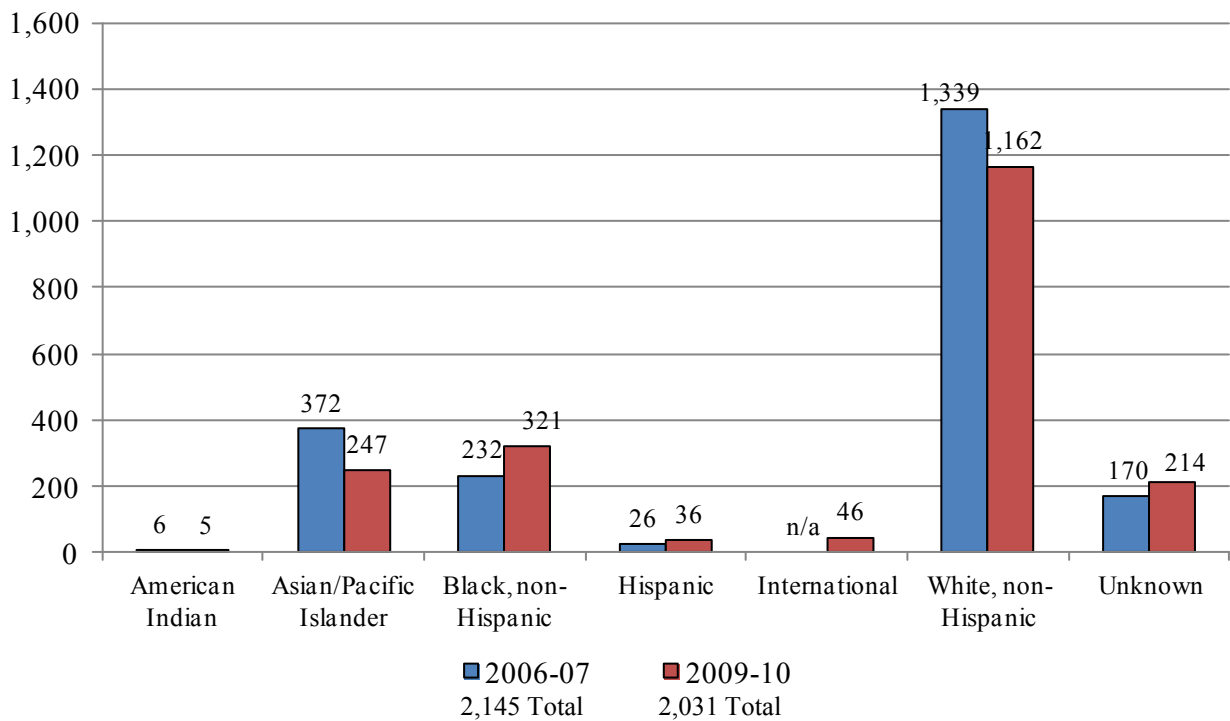

Graduate Fall Enrollment

The Graduate level headcount and credit hours for fall 2010 decreased by 4.9 % and 4.2% respectively.

- Credit Hours -2,317 -4.2%

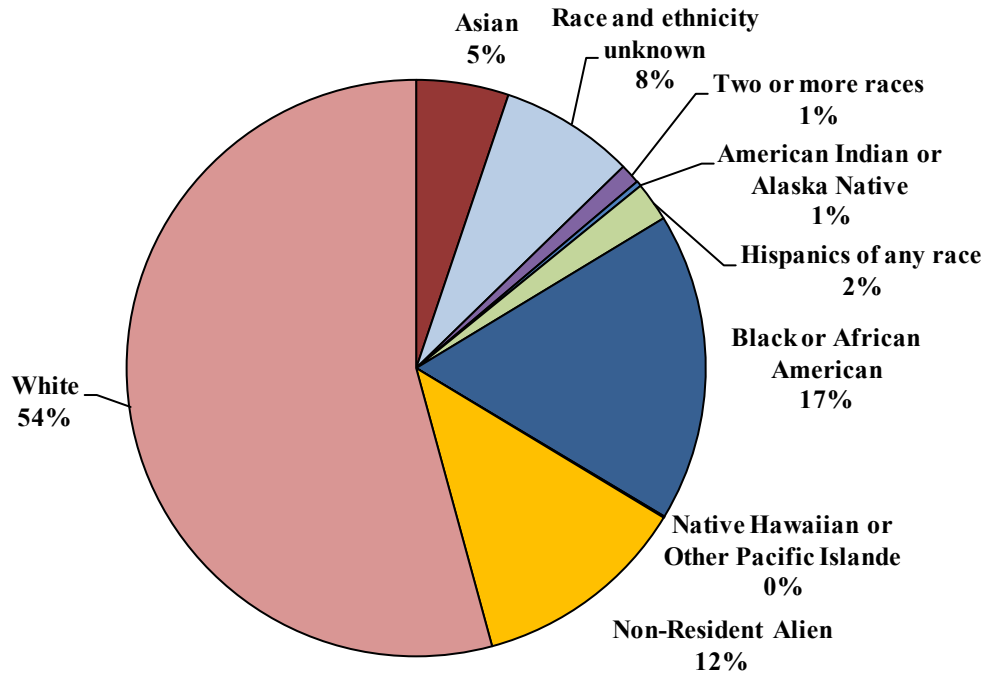

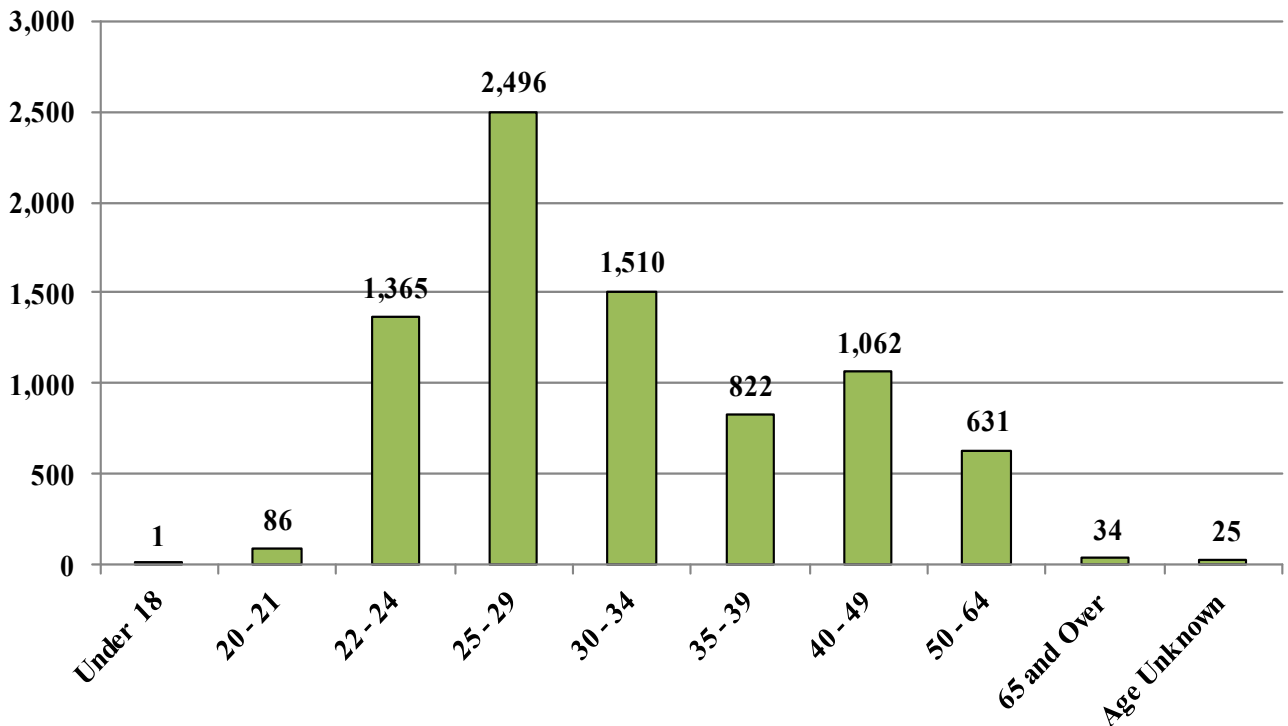

Fall 2011 Graduate Enrollment by Race/Ethnicity

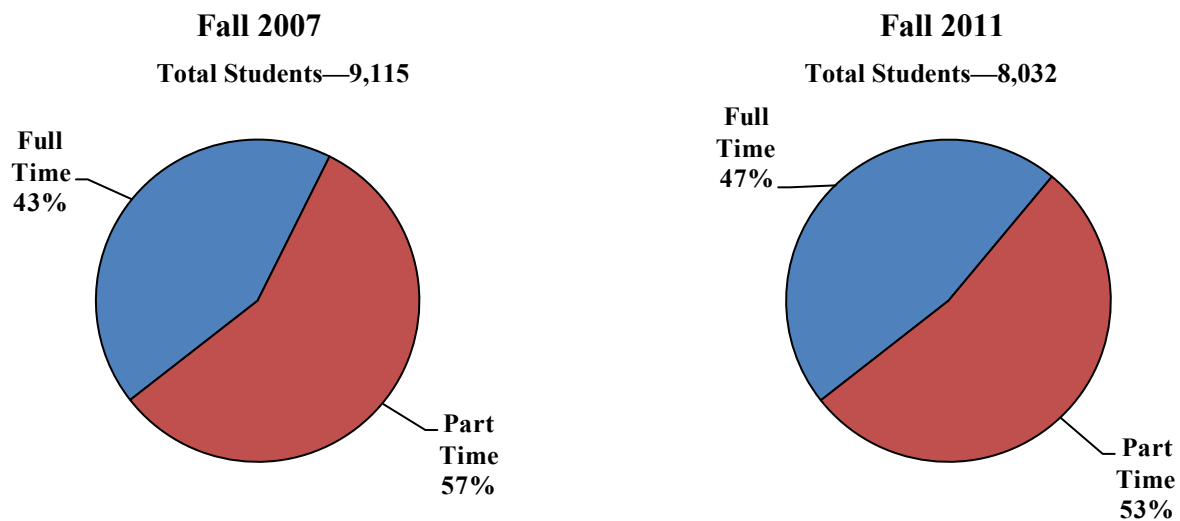


Fall 2011 Graduate Enrollment by Age

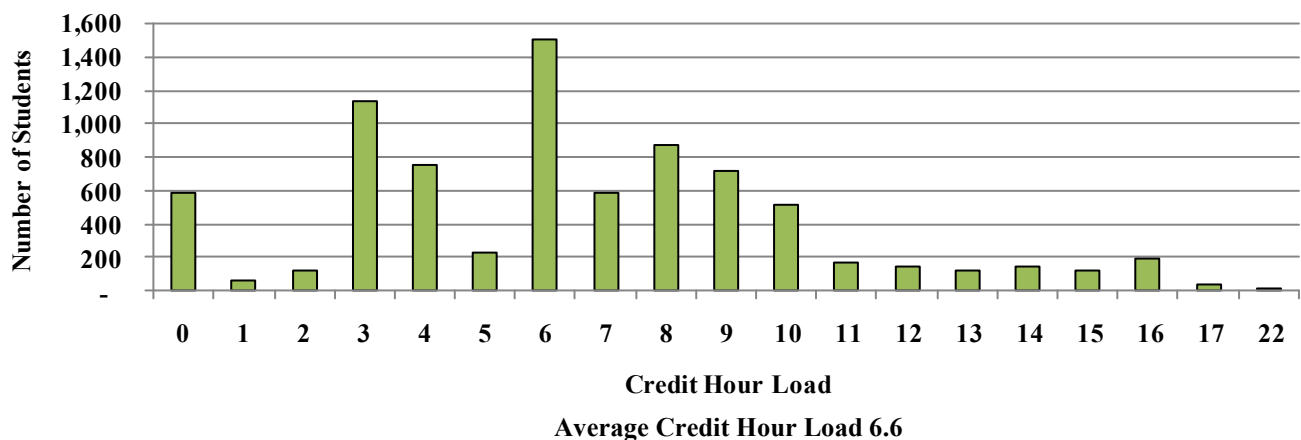
Fall Graduate Enrollment by Time Status Comparison



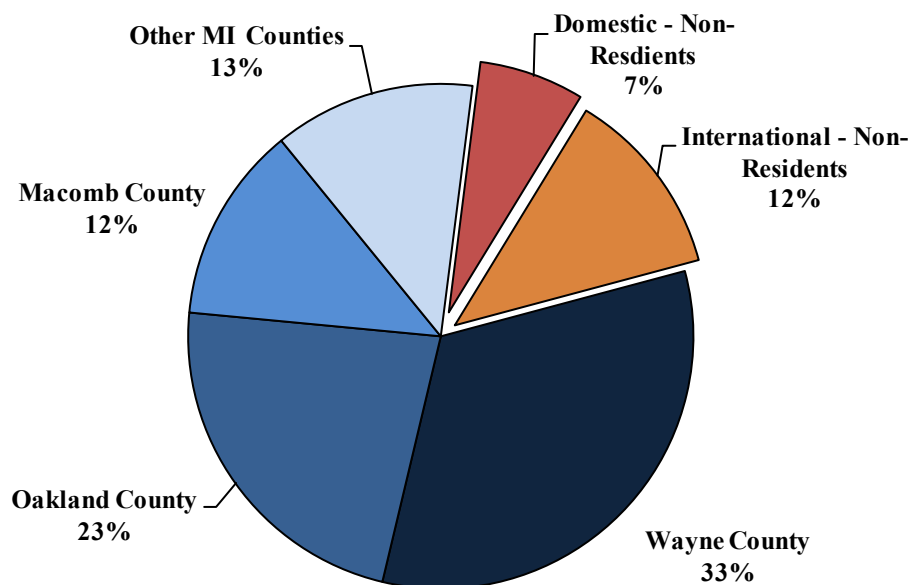

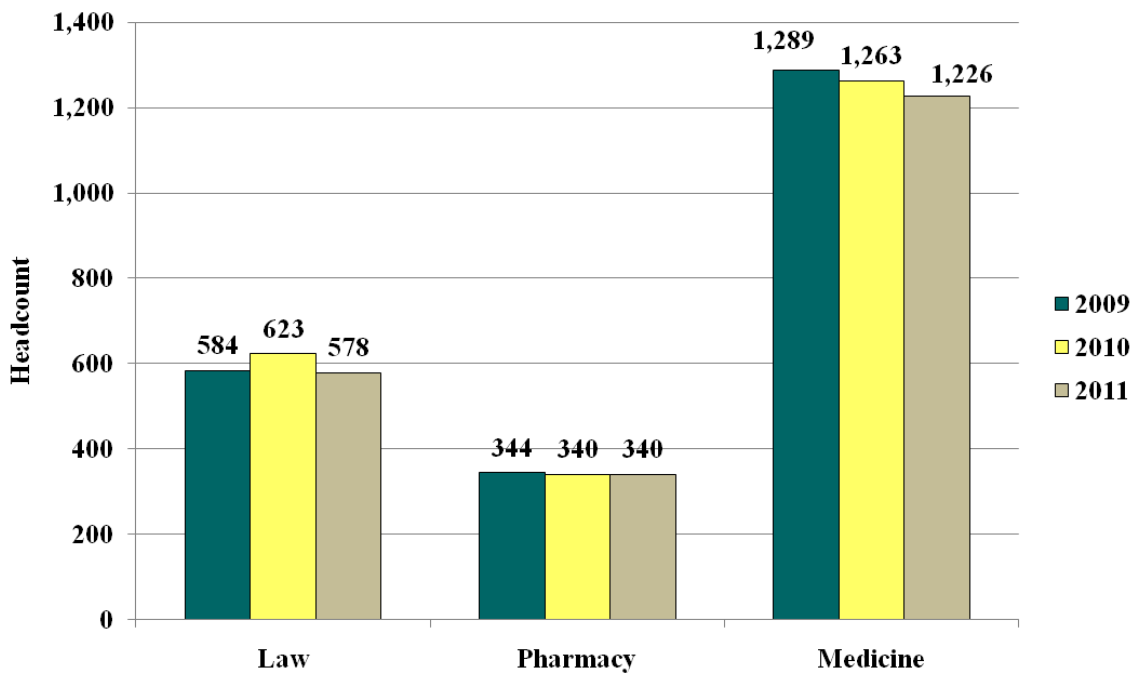

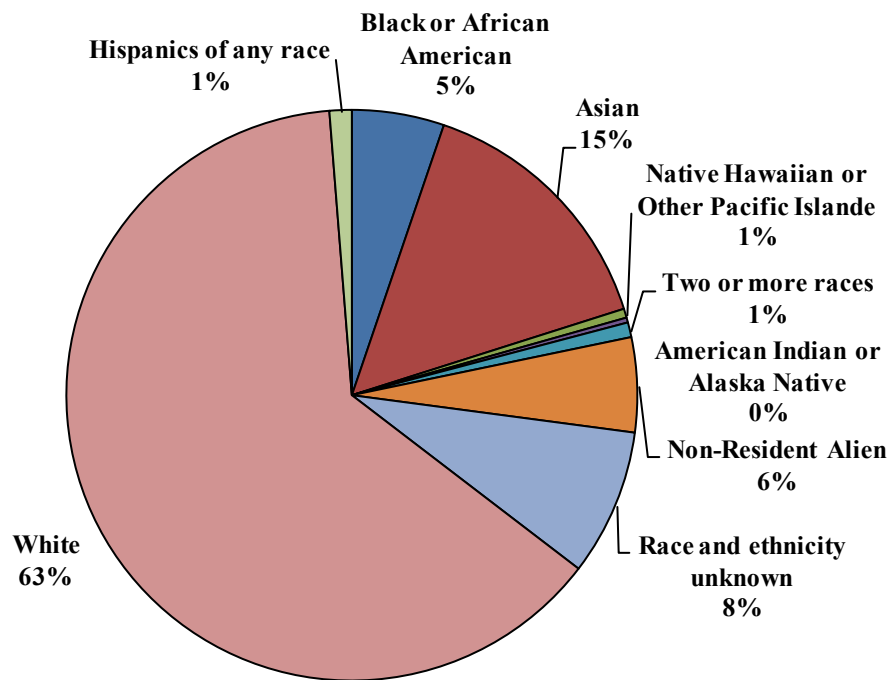

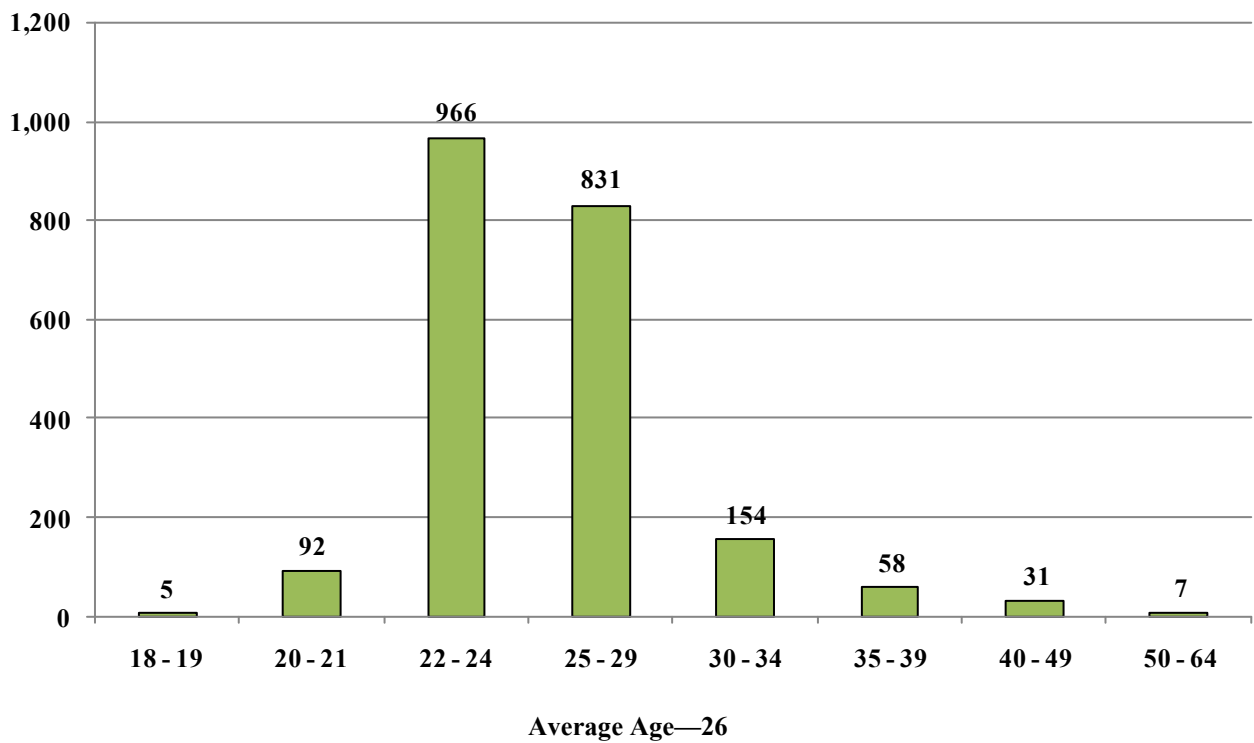
Fall 2011 Professional Student Credit Hour Load Comparison



Fall 2011 Professional Enrollment by Race/Ethnicity

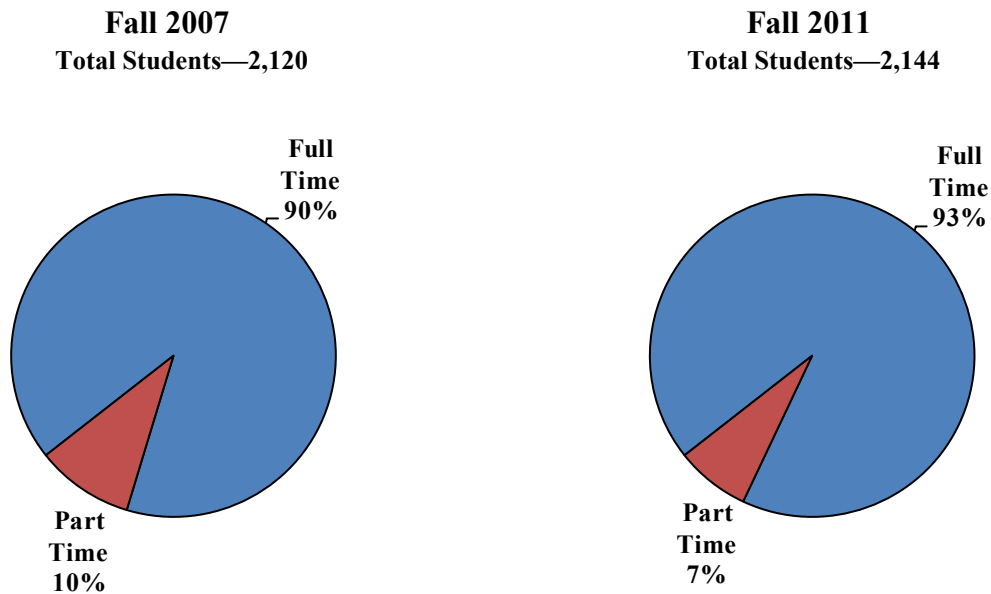


Fall 2011 Professional Enrollment by Age

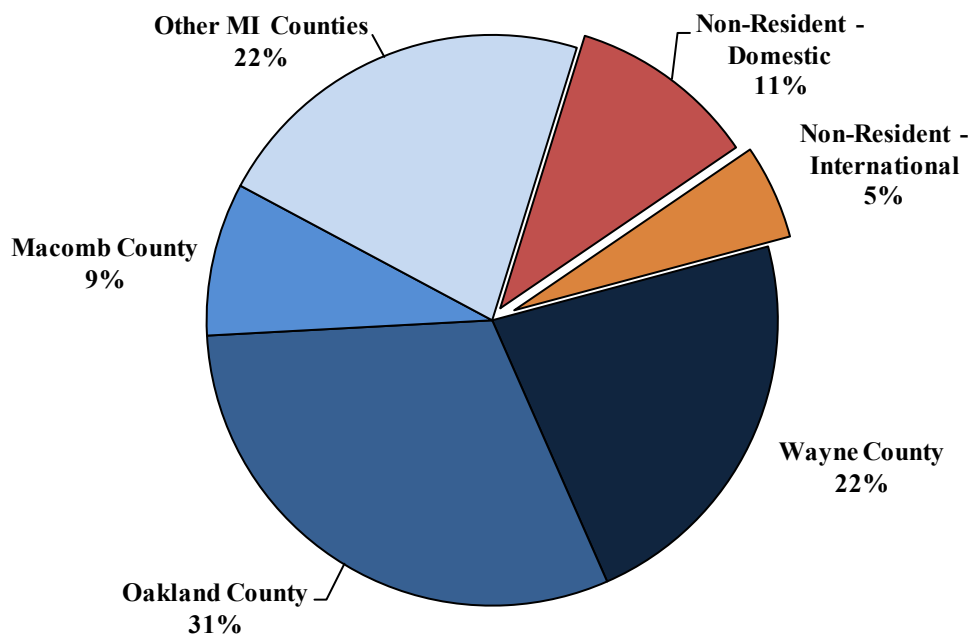
